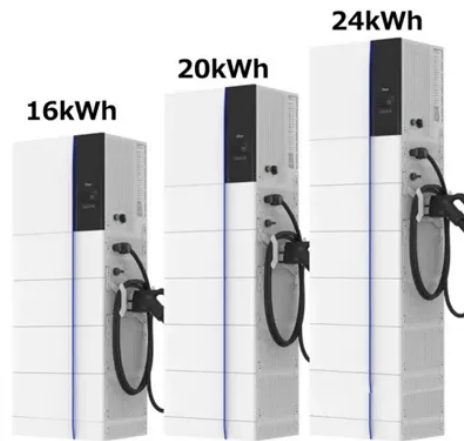


Sweden battery safety

The Battery Regulation contains rules that apply to those who place batteries on the market or use batteries within the EU. The regulation partly replaces the battery directive 2006/66/EC and must be applied from 18 February 2024. Companies outside Sweden selling directly to end users in Sweden also have EPR for batteries. Batteries are a key technology for electrification and play an important role in future energy supply.
